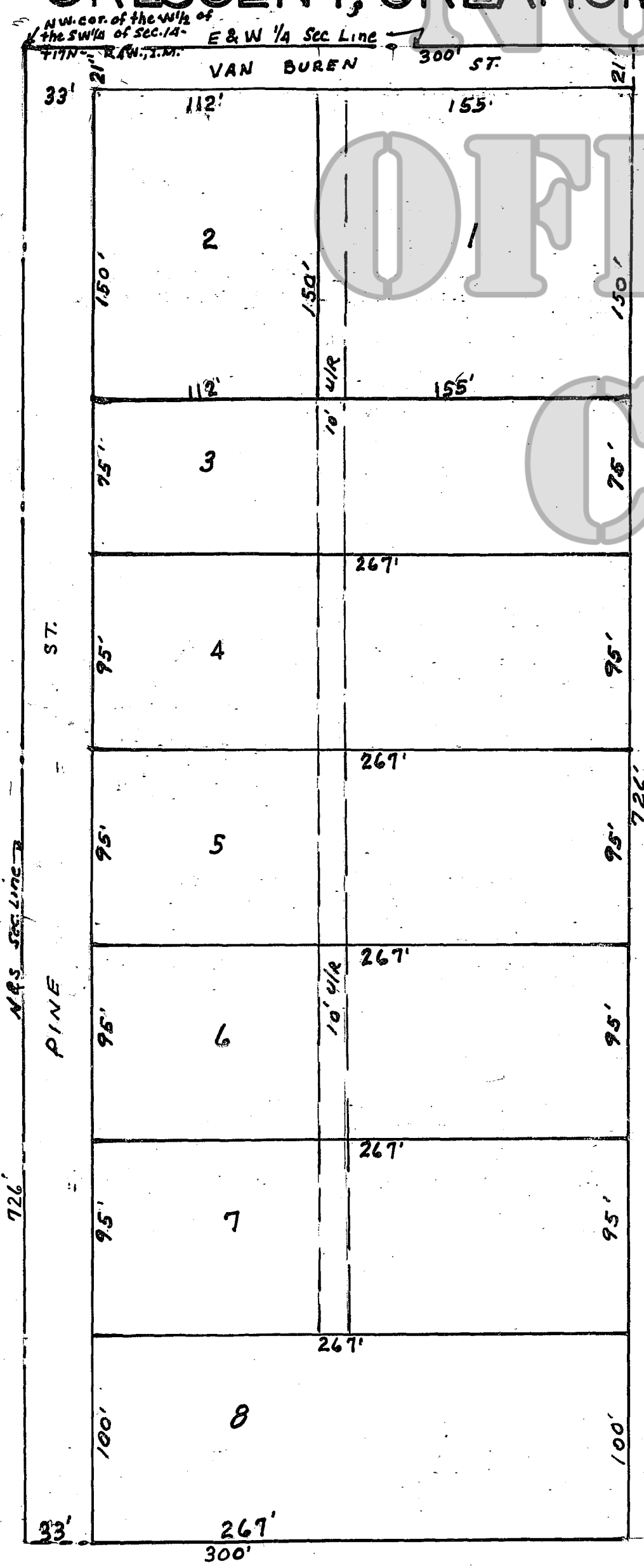


HILDRETH'S ADDITION TO THE TOWN OF CRESCENT, OKLAHOMA

CERTIFICATE OF OWNERSHIP & DEDICATION

Know all men by these presents: That C.M. Hildreth & Velma E. Hildreth, husband and wife, of Logan County, Okla., hereby certify that they are the owners of (surface rights only, until June 11, 1967) the following described tract of land situated in the W¹/₂ of the SW¹/₄ of Sec. 14-T17N-R4W, I.M., described as follows: A tract of land commencing at the NW Corner of the W¹/₂ of the SW¹/₄ of Section 14 - Twp. 17N-Rge 4W, I.M., and running East 300 feet, thence 726 feet South, thence 300 feet West, thence 726 feet North to the point of beginning, except oil, gas and other minerals for a period of 20 years from June 11, 1947; and that they have caused the same to be surveyed and platted into lots and streets, and have designated the same to be known as HILDRETH'S ADDITION TO THE TOWN OF CRESCENT, OKLAHOMA; and do hereby adopt the annexed PLAT as the official plat of same and do hereby dedicate all streets, as shown, to the public.
