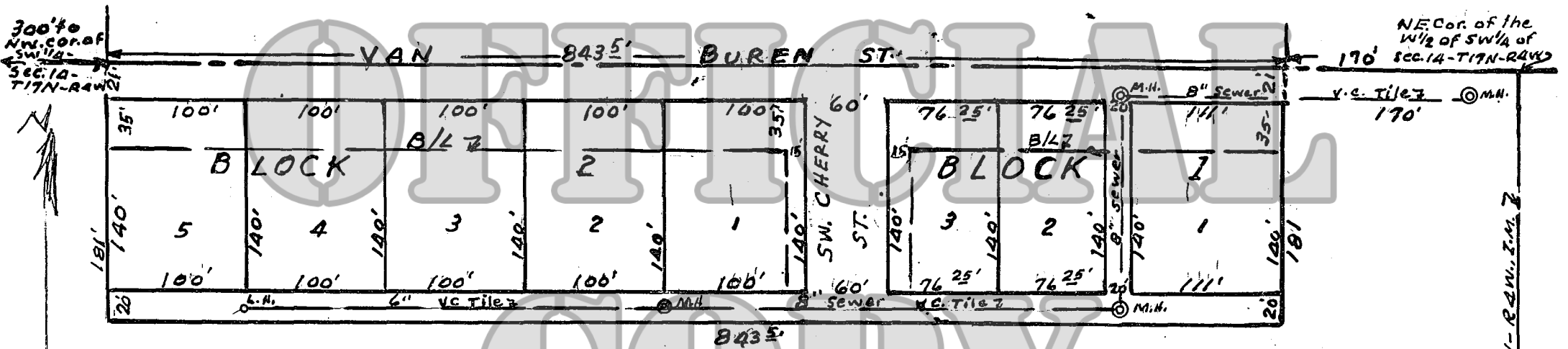


SHAFFER'S ADDITION TO CRESCENT, OKLAHOMA



CERTIFICATE OF OWNERSHIP & DEDICATION

Know all men by these presents: That we, Merle Houck and Ralph W. Willms are owners of the following described tract of land, to-wit: Beginning at a point on the North line of W¹/₂ of the SW¹/₄ of Sec. 14 - T17N - R4W, IM, Logan County, Oklahoma, 170 feet west of the NE corner of W¹/₂ of SW¹/₄ of said Sec. 14, thence South and Parallel with the East line of said W¹/₂ of said SW¹/₄, a distance of 181 feet, thence West and Parallel with the North line of said SW¹/₄, a distance of 843.5 feet, thence North 181 feet, thence East 843.5 feet, to the point of beginning; and we have caused the same to be surveyed and platted into lots, Blocks, Streets and alleys and that we hereby accept and approve the above Plat to be known as SHAFER'S ADDITION TO CRESCENT, OKLAHOMA, as the official plat of the above described tract of land; and we hereby dedicate all streets and alleys for public use. We are the owners of the surface rights only to the above described tract of land.
